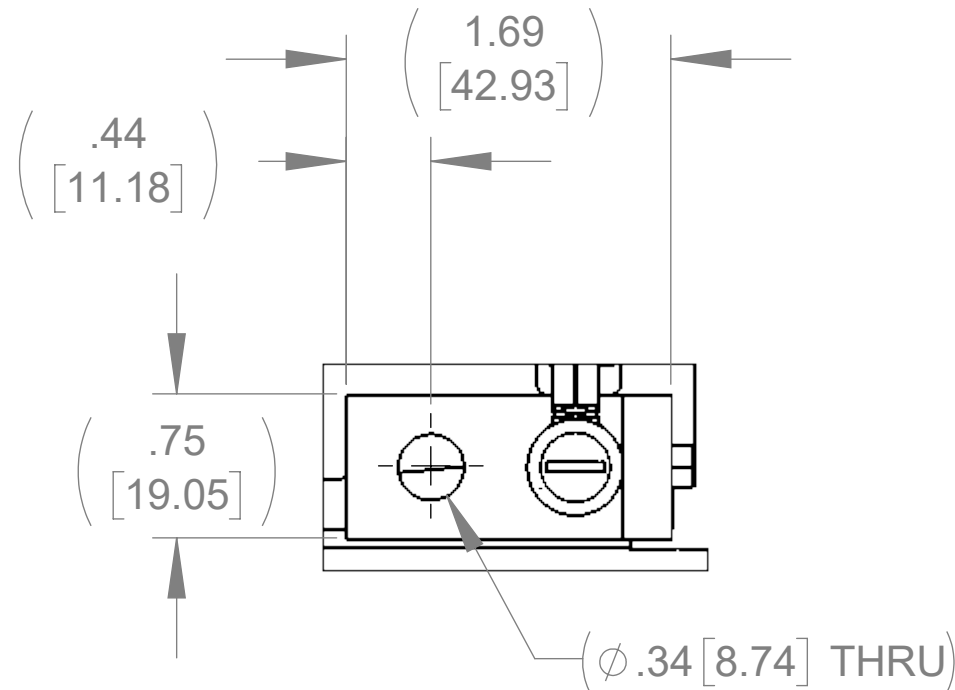
DETAIL B

DETAIL VIEW (3 PLACES)



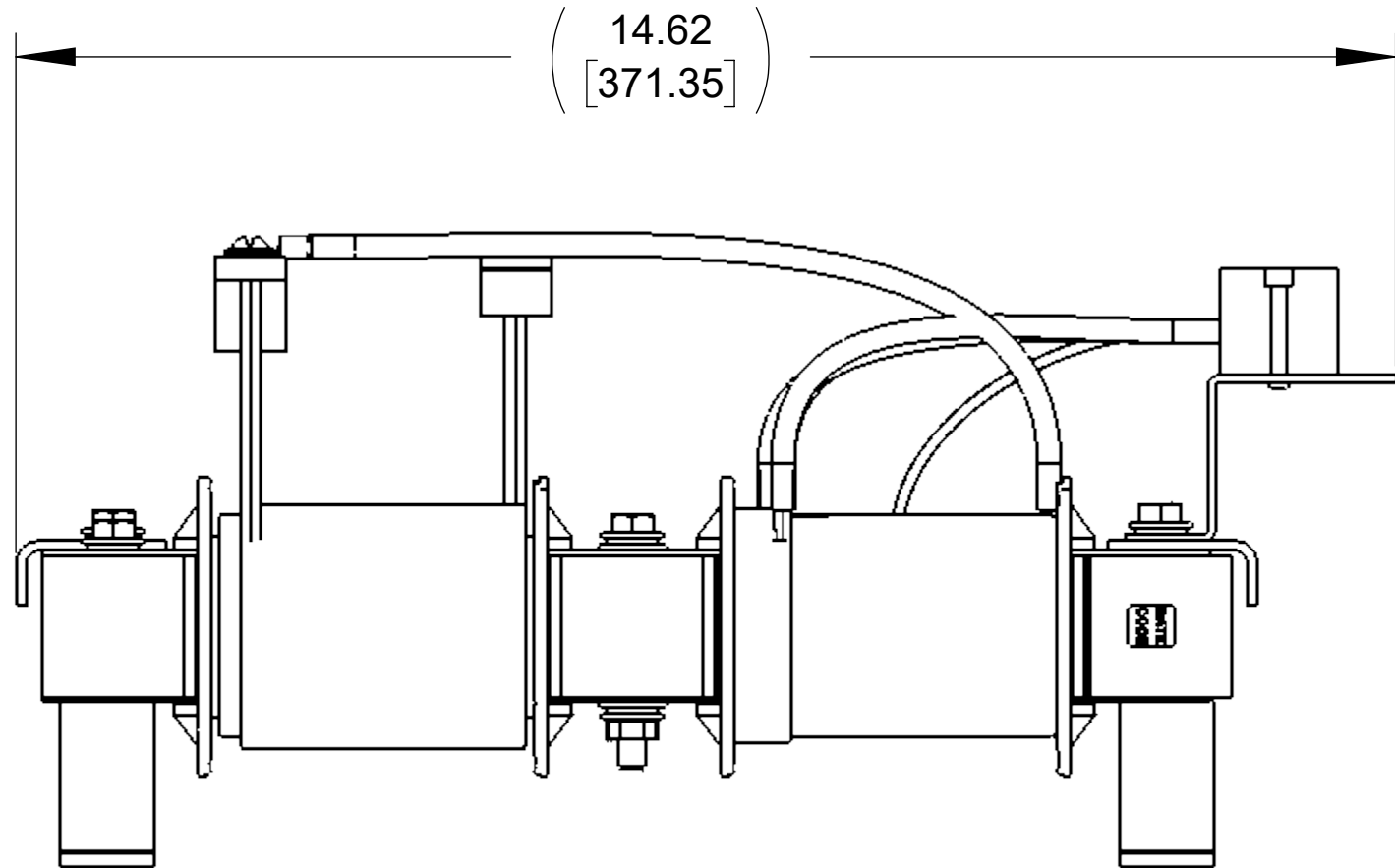
FRONT VIEW



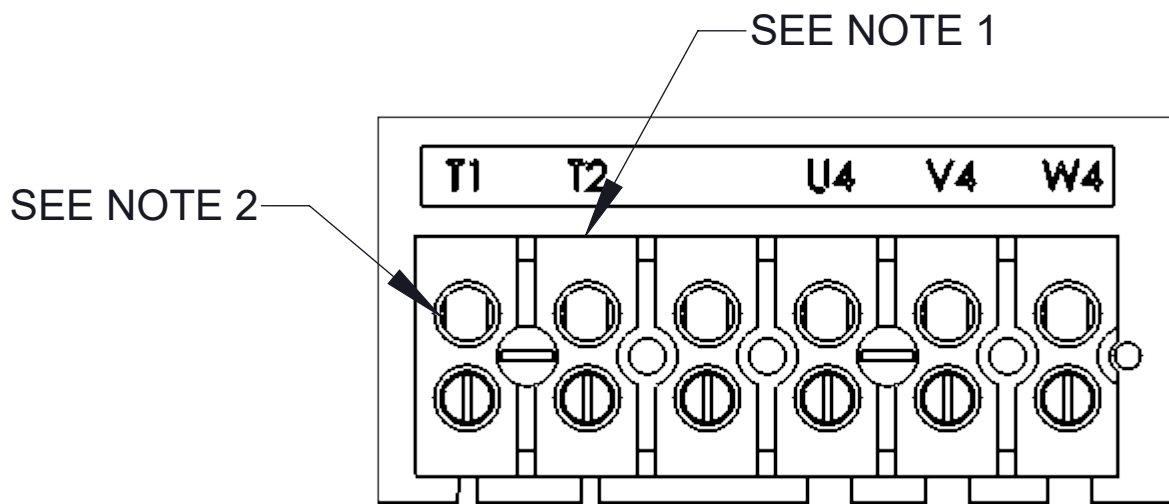

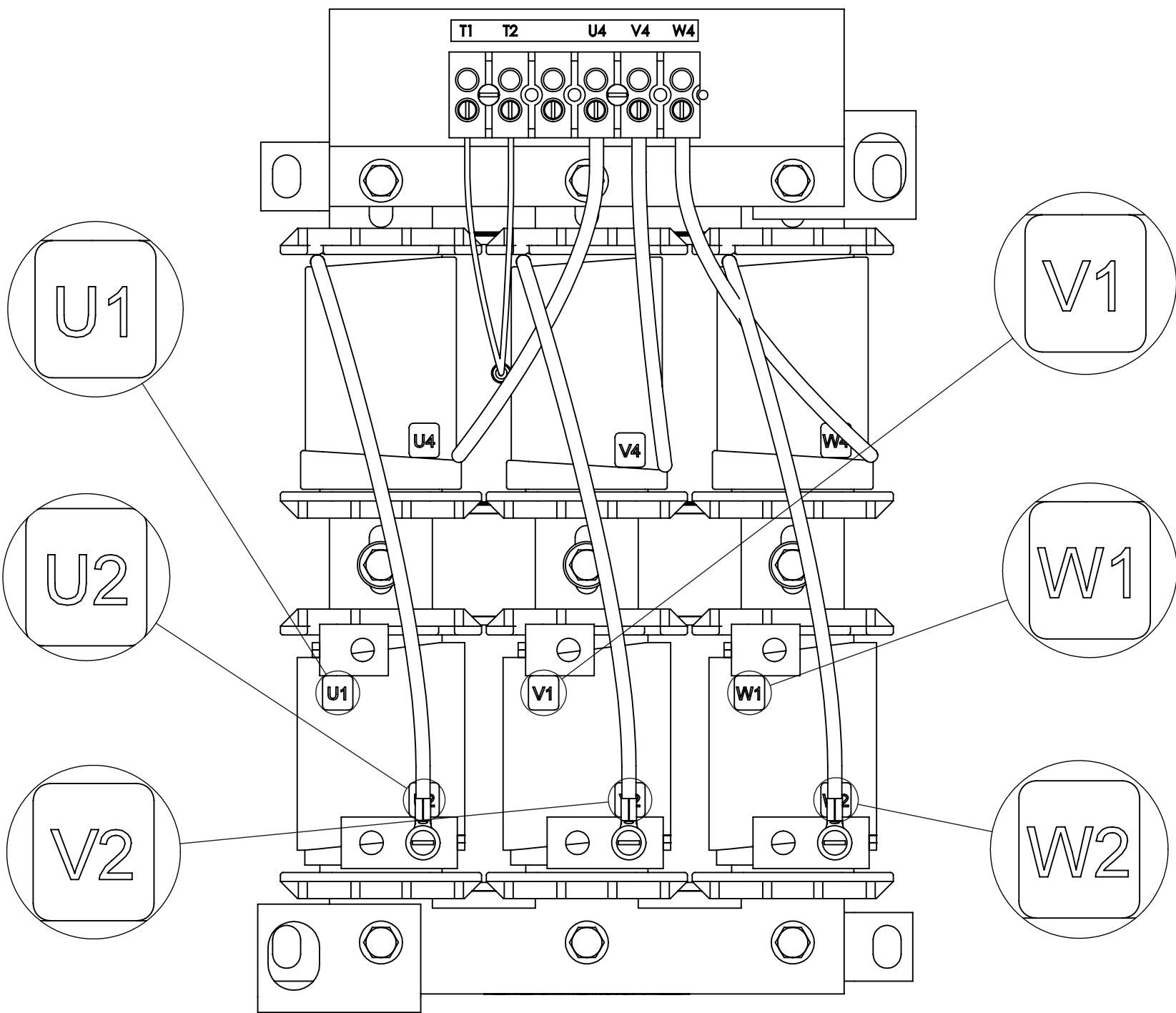

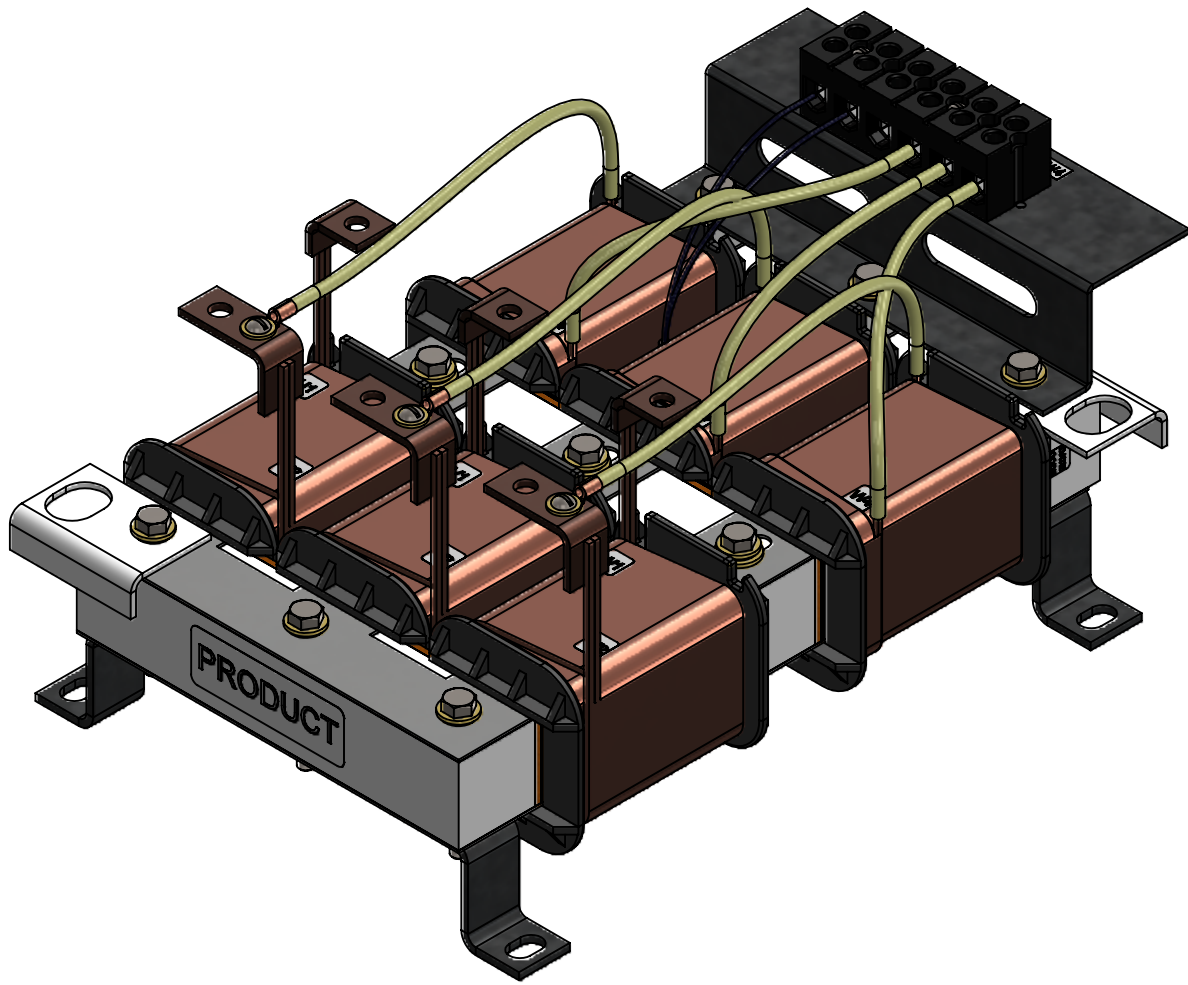
