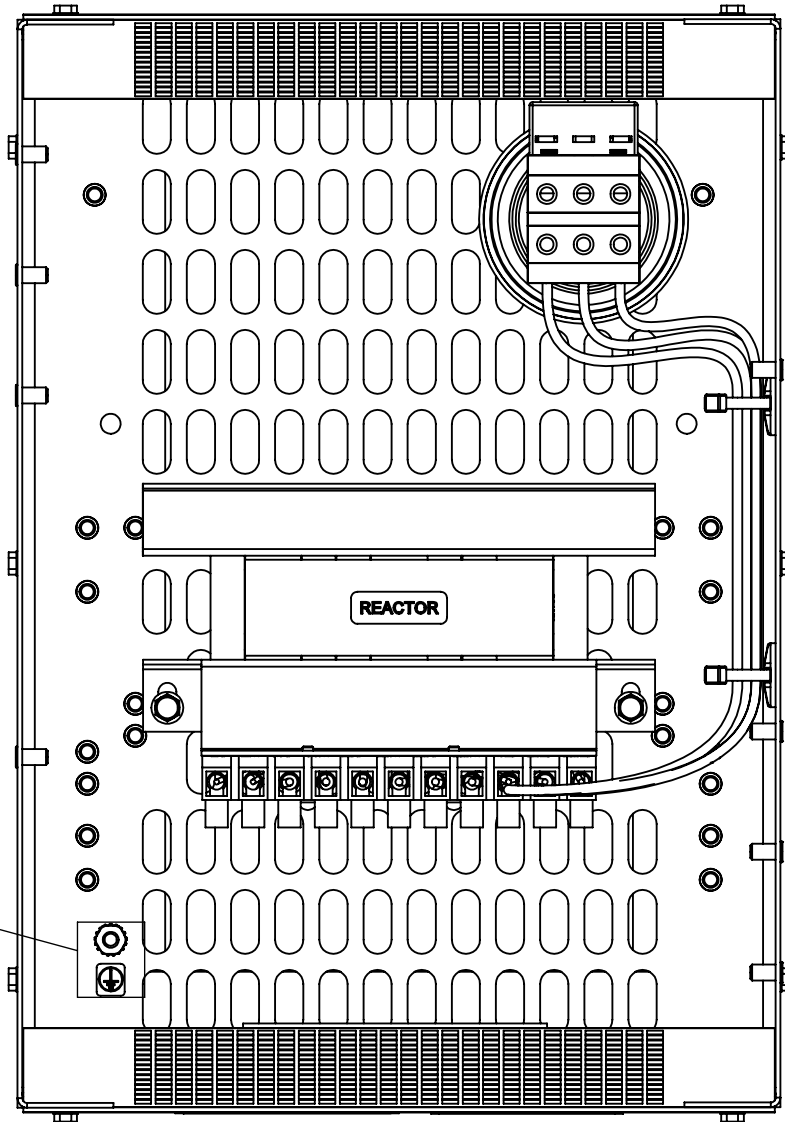
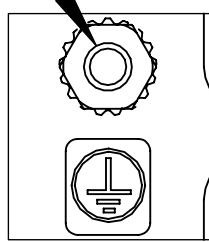


SIDE VIEW

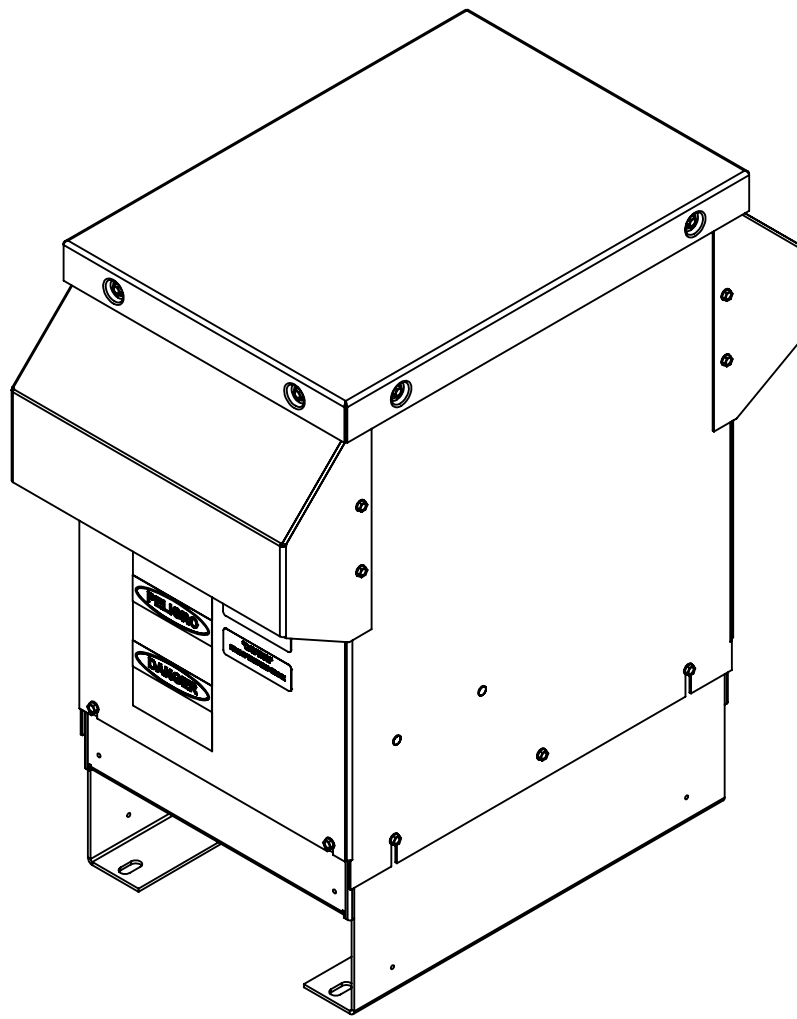

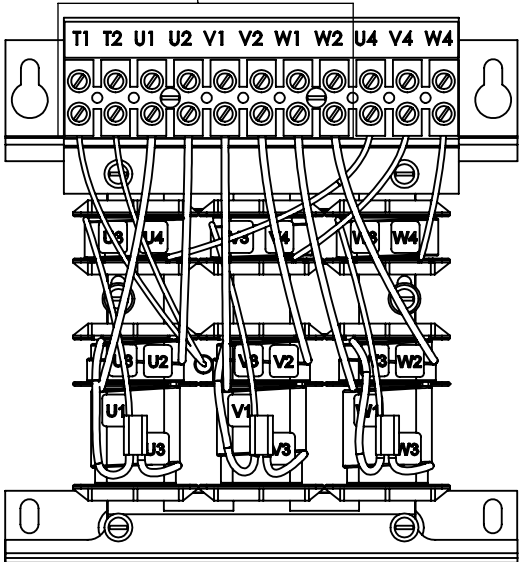
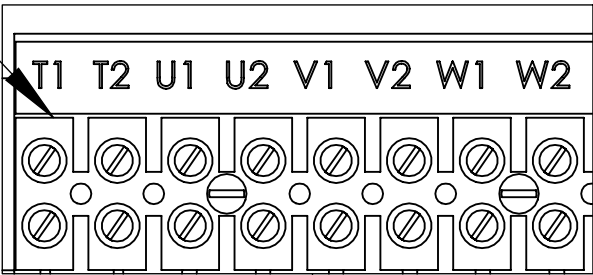
